This report documents the selection of collective agreements in the Eurofound database of collective agreements for low-paid workers. The database includes a sample of collective agreements for each of the selected low-paid sectors of interest. The documentation summarises how the task of identifying relevant agreements was approached, if and to what extent full registers of collective agreements with the required meta-data were available or, in their absence, which other approaches had to be taken. In addition, the documentation includes background information on the relevant member state's sectoral collective bargaining, its actors and functioning, and a description of the sampling approach, as well as basic information on the collective agreements proposed to be included in the database for each of the ten low paid sectors of interest.

Detailed information related to each collective agreement can be found online in the visual dashboard with a live connection to the database.

General information

A database of collective agreements, managed by the Ministry of Social Security and Labour (MSSL) is publicly available in Lithuania at: https://socmin.lrv.lt/lt/paslaugos/administracines-paslaugos/kolektyviniu-sutarciu-registras-ir-kolektyviniu-sutarciu-registravimo-tvarka?lang=lt

This database contains all types of collective agreements - national, sectoral, regional and company-level. According to art. 195 of the Labour Code of the Republic of Lithuania, since mid 2017, all "valid collective agreements must be registered and publicly announced in accordance with the procedure established by the Minister of Social Security and Labour of the Republic of Lithuania. The collective agreement shall be submitted for registration within 20 days of the date of its signing by the trade union or trade union organisation that is a party to the collective agreement. If the trade union or trade union organisation fails to register the collective agreement within this period, the employer or employers' organisation that is the other party to the collective agreement shall acquire the right to submit the collective agreement for registration".

However, the omission of its publication, does not make the agreement invalid. Therefore, while it is safe to assume that all national, sectoral, and territorial level agreements are registered within the database, some company-level agreements might be missing. However, it can be estimated that at least 80-90% of valid company-level agreements are registered in the database.

The database provides a list of agreements, and their full texts (in pdf format) are provided. Neither NACE sectors, nor number of employees covered are provided in the database, but this information can often be received from other sources of information, including MSSL.

1 - Agriculture

Background information

There are several employers' organisations in the agriculture sector in Lithuania, and only one trade union - the Lithuanian Federation of Agricultural Employees' Trade Unions - with less than 400 members in the sector.

The main Employers' organisations are the following:

- Lithuanian Farmers' Union.
- Chamber of Agriculture of the Republic of Lithuania.
- Lithuanian Association of Agricultural Companies.
- Lithuanian Association of Agricultural Cooperatives.

Collective bargaining does not take place in the sector.

Sampling information

According to the publicly available national register of collective agreements, there are no agreements registered in NACE-2 sector of interest A-01 (crop and animal production, hunting and related service activities).

2 - Manufacture of food, leather, textiles, and clothes

Background information

There is one rather active sectoral trade union, operating in the manufacture of food products subsector - the Lithuanian Trade Union of Food Producers (affiliated to the Lithuanian Trade Union Confederation, LPSK). Mainly due to the activity of this trade union, the food manufacturing subsector is one with the highest collective bargaining density in the private sector. In the 'light' (mainly textile) industry sub-sector there are also a few sectoral active trade unions: among them, the Lithuanian Trade Union of Manufacturing Workers (affiliated to LPSK) and the trade union 'Solidarumas' of Lithuanian industrial companies (affiliated to the Lithuanian Trade Union 'Solidarumas') should be mentioned.

There are also several employers/business organisations active in the NACE-2 sectors of interest. However, despite the presence of sectoral trade unions and employers' organisations, sectoral collective bargaining does not take place in the NACE-2 sectors of interest (this applies in general to the whole NACE-1 manufacturing sector).

Only company-level collective agreements are signed. Currently there are approximately 50 agreements registered in the whole manufacturing sector, of which 13 (valid in 2020) relevant to the NACE-2 sectors of interest C-10, C-13, C-14, and C-15.

There is no official information on the collective bargaining coverage in the NACE-2 sectors of interest. However, according to our calculations, it might not be higher than 10%.

Sampling information

All 13 collective agreements (mentioned in the Background section) applicable to the NACE-2 sectors of interest C-10, C-13, C-14, and C-15, registered in the publicly available national register of collective agreements are included in the sample.

Therefore, they cover in total the 100% of all employees working in the NACE-2 sectors of interest who are covered by collective bargaining.

Self-assessed proportion of included agreements

- Virtually all agreements related to 2 Manufacture of food, leather, textiles, and clothes (as defined in the project)
- Nearly all (90% to 100%) of those workers in 2 Manufacture of food, leather, textiles, and clothes (as defined in the project), which are covered by a collective agreement.

3 - Construction excl. civil engineering

Background information

There is one large employer's organisation in the construction sector - the Lithuanian Construction Association - and several trade unions.

Two sectoral unions – the Lithuanian Federation of Industrial Trade Unions (affiliated to the Lithuanian Trade Union Confederation, LPSK) and the Builders' Trade Union 'Solidarumas' (affiliated to the Lithuanian Trade Union 'Solidarumas') – declare having approximately 260 union members in the construction sector in total.

Sectoral collective bargaining does not take place and only company-level agreements are signed. According to the information provided by the national register of collective agreements, there are currently only few agreements signed in the in the whole construction sector, and only one (valid in 2020) applies to the selected NACE-2 sectors of interest F-41 (construction of buildings) and F-43 (specialised construction activities).

There is no official information on collective bargaining coverage in the NACE-2 sectors of interest F-41 and F-43; however, according to our calculations, it might be less than 1%.

Sampling information

Only one collective agreement (valid in 2020), belonging to the selected NACE-2 sectors of interest F-41 (construction of buildings) and F-43 (specialised construction activities) is registered in the national register of collective agreements.

Information on the coverage figures of workers for each agreement might be obtained from two sources: first, from the information on the coverage of each collective agreement, registered at the national register, is presented in the Excel sheet available at the register and provided by the Ministry of Social Security and Labour; second, as the collective agreement is a company-level one, applicable to all employees of the company, information on company employees might be found in publicly available sources providing information about companies (e.g. www.rekvizitai.lt).

- Nearly all (90% to 100%) of those workers in 3 Construction excl. civil engineering (as defined in the project), which are covered by a collective agreement.

4 - Retail

Background information

There are few sectoral trade unions unionizing a small number of retail employees: the Lithuanian Service Workers Trade Union and the Lithuanian Trade Union of Commerce and Cooperation Workers (both affiliated to the Lithuanian Trade Union Confederation, LPSK), and the League of Shopping Centres Employees (affiliated to Trade Union 'Solidarumas').

There is also one comparatively large employer organisation – the Association of Lithuanian Trade Enterprises (affiliated to the Lithuanian Business Confederation, LVK), unionizing all main retail companies operating in Lithuania.

However, collective bargaining does not take place at sectoral level and only few company-level collective agreements are signed.

According to the information provided in the national register of collective agreements, there are currently approximately ten collective agreements in the whole commerce sector, of which eight (valid in 2020) belong to the selected NACE-2 sector of interest G-47 (retail trade, except of motor vehicles and motorcycles.

There is no official information on the collective bargaining coverage in the NACE-2 sector of interest G-47; however, according to our calculations, it might be close to 10-15%, due to the collective agreement signed by the largest retail company in Lithuania – Maxima.

Sampling information

Out of the approximately ten agreements (mentioned in the Background tab) applicable to the NACE-2 sector of interest G-47 (retail trade, except of motor vehicles and motorcycles), the largest ones are included in the sample.

Information on the coverage figures of workers for each agreement might be obtained from two sources: first, from the information on the coverage of each collective agreement, registered at the national register, is presented in the Excel sheet available at the register and provided by the Ministry of Social Security and Labour; second, as the collective agreement is a company-level one, applicable to all employees of the company, information on company employees might be found in publicly available sources providing information about companies (e.g. www.rekvizitai.lt).

- Virtually all agreements related to 4 Retail (as defined in the project)
- Nearly all (90% to 100%) of those workers in 4 Retail (as defined in the project), which are covered by a collective agreement.

5 - Postal, courier, land transport and warehouses

Background information

The transport sector in Lithuania is comparatively well organised.

There are several rather active sectoral trade unions and employers' organisations:

- The Lithuanian Association of Railway Workers Trade Unions (affiliated to the Lithuanian Trade Union Confederation, LPSK).
- The Lithuanian Federation of Roads and Transport Workers Trade Unions (also affiliated to the Lithuanian Trade Union Confederation, LPSK).
- The Federation of Transport Employees (all three affiliated to the Lithuanian Trade Union 'Solidarumas').
- The Railway Workers Trade Union (affiliated to General Trade Union of the Republic of Lithuania).
- The Trade Union of Lithuanian Transport and Manufacturing Employees (also affiliated to General Trade Union of the Republic of Lithuania).

The main employers' organisation is the Linava – association of almost 700 companies operating in the transport sector with approximately 54,000 employees in total.

Apart from the Lithuanian Railways sectoral collective agreement, only company-level agreements are signed in the transport sector in Lithuania. There are currently approximately 30 agreements registered in the national register of collective agreements in the whole NACE-1 transport sector, of which approximately 25 were valid in 2020.

There is no national information on the collective bargaining coverage in the NACE-2 sectors of interest H-49 (land transport and transport via pipelines), H-52 (warehousing and support activities for transportation), and H-53 (postal and courier activities); however, according to our calculations, it might be around to 15-20%. Approximately half of all sectoral employees covered by collective bargaining are employees of Lithuanian Railways and Lithuanian Post.

Sampling information

The eight largest collective agreements are listed, out of approximately 25 (valid in 2020), registered at the national register and applicable to the NACE-2 sectors of interest H-49 (land transport and transport via pipelines), H-52 (warehousing and support activities for transportation), and H-53 (postal and courier activities) providing a coverage of over 80% of workers covered by collective bargaining employed in these three NACE-2 sectors of interest.

Information on the coverage figures of workers for each agreement might be obtained from two sources: first, from the information on the coverage of each collective agreement, registered at the national register, is presented in the Excel sheet available at the register and provided by the Ministry of Social Security and Labour; second, as the collective agreement is a company-level one, applicable to all employees of the company, information on company employees might be found in publicly available sources providing information about companies (e.g. www.rekvizitai.lt).

6 - Hospitality

Background information

There is one representative employers' organisation in the sector – the Association of Hotels and Restaurants; however, there is no sectoral trade union.

According to the information provided in the national register of collective agreements, there is only one company-level collective agreement in NACE-2 sector of interest I-56 (food and beverage service activities), but it was signed only in 2021 and it covers only 45 employees.

No other agreements were identified for the period 2015-2022.

Sampling information

As already explained in the Background section, no collective agreements were identified in NACE-2 sectors of interest I-55 (accommodation) and I-56 (food and beverage service activities) in the period 2015-2022, apart from the agreement (also mentioned in the Background section) signed only in 2021 and covering only 45 employees (and therefore not listed in the sample).

7 - Business support services

Background information

Industrial relations are poorly developed in the NACE-1 sector of administrative and support service activities in Lithuania.

In NACE-2 sector of interest N-78 (employment activities) the most active employers' organisation is the Association of Lithuanian Employment Agencies, uniting private (temporary) work agencies, but no trade union were identified.

In the NACE-2 sector of interest N-80 (security and investigation activities) there is one business association - the Security Business Group.

There are also two sectoral trade unions, operating in the NACE-2 sectors of interest N-80, N-81 and N-82 – the Lithuanian Service Employees Trade Union and United Trade Union of Communal Economy Employees, but they have no more than 100 sectoral employees together.

Sectoral collective bargaining does not take place, and only one company-level collective agreement has been identified.

There is no official information on the collective bargaining coverage in the NACE-2 sectors of interest N-78, N-80, N-81, and N-82; however, according to our calculations, it might be close to 1-2% only.

Sampling information

There is only one collective agreement registered at the national register, as mentioned in the Background section.

Information on the coverage figures of workers for each agreement might be obtained from two sources: first, from the information on the coverage of each collective agreement, registered at the national register, is presented in the Excel sheet available at the register and provided by the Ministry of Social Security and Labour; second, as the collective agreement is a company-level one, applicable to all employees of the company, information on company employees might be found in publicly available sources providing information about companies (e.g. www.rekvizitai.lt).

8 - Residential and social care

Background information

The social work/social care sector is rather well organised in Lithuania on the side of trade unions. Sectoral trade unions, representing social (care) workers exist in all three national trade union confederations.

A sectoral collective agreement has been signed since 2018. As there are no employer organisations representing companies in this private sector, the sectoral collective agreement is signed by the Ministry of Social Security and Labour, which assumes the role of main sectoral employer.

Apart from the mentioned sectoral collective agreement, up to 20 company-level collective agreements are registered in the national register in the social services sector; approximately 15 of them were valid in 2020.

There is no national information on the collective bargaining coverage in the NACE-2 sectors of interest Q-87 (residential care activities) and Q-88 (social work activities without accommodation). However, according to our calculations, it might be close to 15-20%.

Sampling information

The sectoral agreement mentioned in the Background section and the two largest company-level agreements are listed.

There exist, apart from the listed ones, 12-14 further company-level collective agreements valid in 2020, covering approximately 1,400 employees in total. All of the above-mentioned collective agreements are signed in social care homes or social assistance centres.

Collective agreements signed in the social care sector are generally applicable to employees members of signatory trade unions only. Information on the coverage figures of workers for each agreement might be obtained from the Excel sheet available at the register and provided by the Ministry of Social Security and Labour.

9 - Arts, gambling and sports

Background information

There are several trade unions in the NACE-1 sector of arts, entertainment, and recreation sector in Lithuania:

- The Lithuanian Federation of Culture Sector Trade Unions (affiliated to the Lithuanian Trade Union Confederation, LPSK).
- The Lithuanian Federation of Theatres and Concert institutions Trade Unions (also affiliated to the Lithuanian Trade Union Confederation, LPSK).
- The Trade Union of Lithuanian Cultural Employees (affiliated to General Trade Union of the Republic of Lithuania, RJPS).

As there are no employers' organisations in the sector, the Ministry of Culture assumes the role of main sectoral employer.

The sectoral collective agreement signed by the RJPS and the Ministry covers the "cultural sector", but there is no publicly available information on the sub-sectors covered by this agreement.

There is also one company-level collective agreement registered in the national register of collective agreements, relevant for the NACE-2 sector of interest R-90 (creative, arts and entertainment activities): the collective agreement of National Opera and Ballet Theatre.

There is no official information on the collective bargaining coverage in the NACE-2 sectors of interest R-90 (creative, arts and entertainment activities), R-92 (gambling and betting activities), and R-93 (sports activities and amusement and recreation activities); however, according to our calculations, it might be close to 15-20%.

Sampling information

Both agreements mentioned in the Background section are listed, covering 100% workers employed in the NACE-2 sectors of interest R-90 (creative, arts and entertainment activities), R-92 (gambling and betting activities), and R-93 (sports activities and amusement and recreation activities) who are covered by collective bargaining (since they are the only two existing collective agreements in these NACE-2 sectors, according to the national register of collective agreements).
